- 1. Agenda item number one (1) Call to order. The emergency meeting of the GFC on April 13, 2020 was called to order at 3:03 pm.
- 2. Agenda item number two (2) New business presented for discussion and voting: Motion on P/F for graduate students. The current pandemic has created stress and unanticipated challenges for graduate students. A proposal was presented to allow graduate students to convert classes to P/F or audit with major advisor approval. Details of the proposal, including its implications for transcripts, plans of study, and implementation and deadline were discussed. The following motion was made and seconded:
 - Motion: To temporarily waive the GFC by-laws to allow any graduate student to convert a course taken in spring 2020 from "graded" to either "pass/fail" or "audit", with approval of the student's major advisor (and/or program director).
 - The motion passed on a vote of 45 in Favor and 4 opposed.

- 3. There was a motion offered for adjournment, which was seconded. The motion was passed unanimously and the meeting was adjourned at 3:50 pm.
