- 1. The meeting was held on a Webex site due to the coronavirus.
- 2. Agenda item number two (2) Call to order. The meeting of the GFC for November 18, 2020 was called to order at 3:04 pm.
- 3. Agenda item number three (3) Approval of Minutes. The minutes of the October 28, 2020 meeting of the GFC were presented. There was a motion to accept the minutes offered, which was seconded and the motion was adopted in favor by all members present. **Agenda item number three (3) was passed unanimously without dissent on a voice vote.**
- 4. The Graduate Student Senate Parliamentarian, Irio Schiano, was accompanied by fellow Student Senate members Josh Gil and Spencer Soddenberg. The students expressed their concern with agenda item 5c on the November GFC meeting agenda. After hearing them discuss the issues, it was determined that their discussion should be incorporated with the council discussion when the meeting reaches that point.
- 5. Agenda item number five (5) Old Business (for voting)

a. Presented for consideration and voting: Proposed Elimination of Related/Foreign Language Requirement. The suggested action was to delete Section VII.D of GFC By-laws ("Related Area and/or Foreign Language Requirement for Ph.D.") and all references to it in the GFC By-laws. After reviewing how our peer and aspirant universities treat this issue, the following motion was made and seconded

<u>Motion:</u> Delete Section VII.D of GFC By-laws ("Related Area and/or Foreign Language Requirement for Ph.D.") and all references to it in the GFC By-laws. The motion was approved unanimously. Agenda item 5a was passed unanimously to eliminate the related/foreign language requirement.

b. Presented for consideration and voting: Change in Diploma Terminology
Because accreditation uses the name Sixth Year Certificate for the Neag School of Education's
currently named "Sixth Year Diploma," it was determined that the term "diploma" be
replaced with "certificate" throughout the GFC By-laws. Following a brief discussion, the
following motion was made and seconded:

Motion: Change the name of the Neag School of Education's "Sixth Year Diploma" to "Sixth Year Certificate" (and replace "diploma" with "certificate") throughout the GFC By-laws.

The motion was approved unanimously. Agenda item 5b was passed unanimously to change the name of the Neag School of Education Sixth Year Diploma to Sixth Year Certificate.

c. Presented for consideration and voting: Flexibility regarding Additional Requirements for Ph.D.: Proposed change to Section VII.A.b (Standards and Degree Requirements, Credits, Doctor of Philosophy)

Current Language:

<u>Doctor of Philosophy programs</u>: The Doctor of Philosophy (Ph.D.) requires a minimum of 30 credits of content coursework beyond the baccalaureate (or its equivalent) or at least 15 credits of content coursework beyond the master's degree or other advanced degree in the same or a closely-related field of study (exclusive of any required Related Area), as well as satisfactory completion of at least 15 credits of GRAD 6950 (Doctoral Dissertation Research) or GRAD 6960 (Full-Time Doctoral Dissertation Research). Some programs also require a foreign language or related area (see Section VII.D). The degree will be conferred only after the advisory committee is convinced that the student has developed independence of judgment and mature scholarship in the chosen field.

After a lengthy discussion and multiple suggested amendments to the original proposal, the following final motion was made and seconded:

Motion: To approve the following changes to Section VII.A.b of the GFC by-laws:

<u>Doctor of Philosophy programs</u>: The Doctor of Philosophy (Ph.D.) requires a minimum of 30 credits of content coursework beyond the baccalaureate (or its equivalent) or at least 15

Clean Copy of Approved New Language:
